I/We agree with Thommo's Camper Trailer Sales and Hire;

The equipment set out above at the rates and for the period given above on the following terms and conditions:-

1. I will pay you the security bond in full (\$400) on picking up your equipment;
2. I will pay you all hire charges in full prior to collecting the equipment;

3. I will pick up the equipment before 5.00pm on the start date and note that the equipment may not be collected or returned on a Saturday or a Sunday unless by prior arrangement.
4. I will check trailer wiring is working and a 7 pin plug (Small ) is fitted prior to pickup.
5. I will ensure that whilst towing your equipment the vehicle will be driven only by me or the other designated drivers and I warrant that I and the other designated driver are fully competent to drive a vehicle whilst towing your equipment.
6. I will return your equipment on the due date, thoroughly cleaned and in good order and condition.
7. If for any reason beyond my control I am not able to return your equipment on the due date I will notify you before that date and will pay addition hire charges at the applicable daily rate.
8. I will at all times use your equipment in accordance with any manufacturers instructions or instructions provided by you with that equipment and/or government regulations pertained to the use of that equipment.
9. I will not overload the camper trailer beyond its limits ie. 750kgs
10. I will ensure that the camper trailer is adequately secured, locked and protected from the environment or other adverse conditions.
11. I will not use the camper trailer for the carrying of any explosive or corrosive substance.
12. I will pay all charges for cleaning and repairing any of your equipment not returned to you thoroughly cleaned and in good order and condition.
13. You are entitled to deduct from our security bond all charges for additional days hire, cleaning and repair of their equipment and replacement of any items not returned and not repairable and your costs of retrieving the equipment should I fail to return it.
14. I will promptly repair any punctured tyres in any of your equipment whilst on hire to me but should a tyre require a replacement through normal wear and tear or accident or damage you are to reimburse me for the cost of replacing such tyre but only if:-
  - (a) I have first notified you of the need for replacement;
  - (b) Replacement tyre is of the same size and make as the damaged tyre or such other size and make as you have first approved;
  - (c) The damage does not arise from adverse conditions such as my towing equipment other than on a fully formed road or continuing to tow the equipment after the tyre is punctured;
  - (d) I have provided you with a detailed receipt for the costs of replacing that tyre.
12. You will insure the equipment against accidental loss or damage, fire and theft but I will pay the first Five Hundred Dollars (\$500.00) of any damage resulting from an accident. Should a third party be responsible for damages caused to any of your equipment by result of a accidental or malicious collision and the claim can be proved

against that third party and you have recovered damages from that third party or another then you will refund to me any part of the \$500.00 excess which I have previously paid, less any legal costs involved.

13. You are not responsible or liable to me for any accommodation fees, loss of deposits or any other expenses arising from the failure of one of your campers either through accidental damage, breakdown or similar event during the period of the hire.
14. I will ensure that the equipment is used with care and due consideration for other persons and it is agreed that any reckless use of the towing vehicle or the equipment will result in termination of this Agreement.
15. I will reimburse you for all damage or injury to the equipment caused by water whether due to water crossing or part of total immersion in water or any other fluid for any reason.
16. I will pay any parking and traffic violations incurred during the period of the hire or in respect of your equipment.
17. I will bear any costs incurred by you in retrieving the equipment should I fail to return it by the due date.

I acknowledge that I have read the foregoing terms and conditions and that the equipment is delivered to me in good order and condition.
